The Board of County Commissioners of Grant County, Oklahoma on behalf of the Grant County District Three (3) are requesting bids for the following:

CONSTRUCTION ONLY FOR BRIDGE #321

SEALED BIDS, submitted on forms prepared by the Board of County Commissioners of Grant County, Oklahoma, and the outside of the bid envelope shall be clearly marked "**SEALED BID 05-2017**" with closing date and time, will be received by the County Clerk in Room 102, Grant County Courthouse, 112 E Guthrie, Medford, Oklahoma 73759, until 4:30 p.m., Thursday, May 11, 2017. Bids received prior to 4:30 p.m., Monday, April 10, 2017 AND bids received after 4:30 p.m., Thursday, May 11, 2017, will be rejected. All bids timely received will be publicly opened and read aloud on Monday, May 15, 2017, in Room 103 of the Grant County Courthouse during the regularly scheduled meeting of the Board of County Commissioners.

"AFFIDAVIT FOR FILING WITH COMPETITIVE BID", "BUSINESS RELATIONSHIP AFFIDAVIT", "CERTIFICATION OF NON-DISCRIMINATION IN EMPLOYMENT", AND "AFFIDAVIT OF COMPLIANCE" MUST HAVE ALL BLANK SPACES FILLED IN, AND MUST BE SIGNED WITH IN BLUE INK, NOTARIZED AS REQUIRED AND RETURNED WITH BID OR BID WILL NOT BE ACCEPTED". ADDITIONALLY, INTERNAL REVENUE SERVICE FORM W-9 MUST BE ATTACHED TO THE BID SUBMITTED.

If the bid is Fifty Thousand Dollars ((\$50,000.00) or greater, the bid shall be accompanied by a certified check, cashier's check or bid bond approved by the County in an amount of not less than five percent (5%) of the amount of the bid as a guarantee that, if awarded the contract, the bidder will enter into a contract with the Board of County Commissioners for the execution of the above-stated work, and in the event of failure to do so, there shall be paid to the County the sum of five percent (5%) of said bid as liquidated damages. The Bid Bond must have a duly executed Power of Attorney attached to show that the individual signing the bond has been granted that authority by the Surety.

The Board reserves the right to reject any and all bids.

The Board reserves the right to waive informalities or minor irregularities in the bid.

All bids will receive consideration without regard to race, color, religion, sex, age, national origin or handicapped status.

No questions regarding bids, other than bid procedures, will be accepted after 4:30 p.m. on April 25, 2017. All question and responses will be provided to all bidders in the form of a formal addendum approved by the Board of County Commissioners on May 2, 2017.

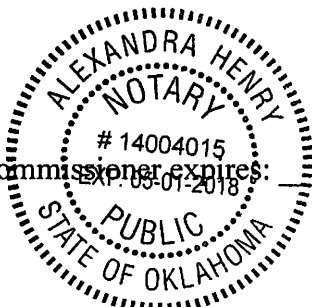
