

Stinson moved to approve the above tax roll corrections as presented. Herod seconded. Stinson-aye, Lamb-absent, Herod-aye. Motion carried.


At 8:50 a.m. Stinson moved to adjourn. Herod seconded. Stinson-aye, Lamb-absent, Herod-aye. Motion carried.
